Color (Blue)

The color should be blue, blue-mottled or blue speckled with or without other markings. The permissible markings are black, blue or tan markings on the head, evenly distributed for preference. The forelegs tan midway up the legs and extending up the front to breast and throat, with tan on jaws; the hindquarters tan on inside of hindlegs, and inside of thighs, showing down the front of the stifles and broadening out to the outside of the hindlegs from hock to toes. Tan undercoat is permissible on the body providing it does not show through the blue outer coat. Black markings on the body are not desirable.

Color (Red Speckle)

The color should be of good even red speckle all over, including the undercoat, (neither white nor cream), with or without darker red markings on the head. Even head markings are desirable. Red markings on the body are permissible but not desirable.

Faults

Any departure from the foregoing points should be considered a fault and the seriousness with which the fault should be regarded should be in exact proportion to its degree.

alertness and intelligence. A warning or suspicious glint is characteristic when approached by strangers. Eye color, dark brown. Ears-- The ears should be of moderate size, preferably small rather than large, broad at the base, muscular, pricked and moderately pointed neither spoon nor bat eared. The ears are set wide apart on the skull, inclining outwards, sensitive in their use and pricked when alert, the leather should be thick in texture and the inside of the ear fairly well furnished with hair. Mouth-- The teeth, sound, strong and evenly spaced, gripping with a scissor-bite, the lower incisors close behind and just touching the upper. As the dog is required to move difficult cattle by heeling or biting, teeth which are sound and strong are very important.

Neck

The neck is extremely strong, muscular, and of medium length broadening to blend into the body and free from throatiness.

Forequarters

The shoulders are strong, sloping, muscular and well angulated to the upper arm and should not be too closely set at the point of the withers. The forelegs have strong, round bone, extending to the feet and should be straight and parallel when viewed from the front, but the pasterns should show flexibility with a slight angle to the forearm when viewed from the side. Although the shoulders are muscular and the bone is strong, loaded shoulders and heavy fronts will hamper correct movement and limit working ability.

Body

The length of the body from the point of the breast bone, in a straight line to the buttocks, is greater than the height at the withers, as 10 is to 9. The topline is level, back strong with ribs well sprung and carried well back not barrel ribbed. The chest is deep, muscular and moderately broad with the loins broad, strong and muscular and the flanks deep. The dog is strongly coupled.

Hindquarters

The hindquarters are broad, strong and muscular. The croup is rather long and sloping, thighs long, broad and well developed, the stifles well turned and the hocks strong and well let down. When viewed from behind, the hind legs, from the hocks to the feet, are straight and placed parallel, neither close nor too wide apart.

Feet

The feet should be round and the toes short, strong, well arched and held close together. The pads are hard and deep, and the nails must be short and strong.

Tail

The set on of tail is moderately low, following the contours of the sloping croup and of length to reach approximately to the hock. At rest it should hang in a very slight curve. During movement or excitement the tail may be raised, but under no circumstances should any part of the tail be carried past a vertical line drawn through the root. The tail should carry a good brush.

Gait/Movement

The action is true, free, supple and tireless and the movement of the shoulders and forelegs is in unison with the powerful thrust of the hindquarters. The capability of quick and sudden movement is essential. Soundness is of paramount importance and stiltiness, loaded or slack shoulders, straight shoulder placement, weakness at elbows, pasterns or feet, straight stifles, cow or bow hocks, must be regarded as serious faults. When trotting the feet tend to come closer together at ground level as speed increases, but when the dog comes to rest he should stand four square.

Coat

The coat is smooth, a double coat with a short dense undercoat. The outer-coat is close, each hair straight, hard, and lying flat, so that it is rain-resisting. Under the body, to behind the legs, the coat is longer and forms near the thigh a mild form of breeching. On the head (including the inside of the ears), to the front of the legs and feet, the hair is short. Along the neck it is longer and thicker. A coat either too long or too short is a fault. As an average, the hairs on the body should be from 2.5 to 4 cms (approx. 1-1.5 ins.) in length.

Australian Cattle Dog Breed Standard

General Appearance

The general appearance is that of a strong compact, symmetrically built working dog, with the ability and willingness to carry out his allotted task however arduous. Its combination of substance, power, balance and hard muscular condition must convey the impression of great agility, strength and endurance. Any tendency to grossness or weediness is a serious fault.

Characteristics

As the name implies the dog's prime function, and one in which he has no peer, is the control and movement of cattle in both wide open and confined areas. Always alert, extremely intelligent, watchful, courageous and trustworthy, with an implicit devotion to duty making it an ideal dog.

Temperament

The Cattle Dog's loyalty and protective instincts make it a self-appointed guardian to the Stockman, his herd and his property. Whilst naturally suspicious of strangers, must be amenable to handling, particularly in the Show ring. Any feature of temperament or structure foreign to a working dog must be regarded as a serious fault.

Head and Skull

The head is strong and must be in balance with other proportions of the dog and in keeping with its general conformation. The broad skull is slightly curved between the ears, flattening to a slight but definite stop. The cheeks muscular, neither coarse nor prominent with the underjaw strong, deep and well developed. The foreface is broad and well filled in under the eyes, tapering gradually to form a medium length, deep, powerful muzzle with the skull and muzzle on parallel planes. The lips are tight and clean. Nose black. Eyes-- The eyes should be of oval shape and medium size, neither prominent nor sunken and must express

Special Prizes

ACDCA National Specialty Versatility Award Competition

A Versatility competition shall be held in conjunction with each National Specialty Show to recognize those dogs best demonstrating combined herding ability, trainability, and representation of the breed standard. Rules for this competition shall be included in the published premium list. Copies of these rules must be available upon request and be on the show grounds during competition. The person(s) responsible for record keeping for the duration of the Versatility competition shall be named by the ACDCA Awards/Performance Committee and shall be identified to the ACDCA Board and the National Specialty Show Coordinator prior to the start of the National Specialty.

Versatility Competition Rules

1. To be eligible for a Versatility competition placement, each dog entered must compete in the Versatility Conformation Class, must qualify in a regular Herding Trial class, and must qualify in at least one of the following performance divisions:
 - a. Obedience
 - b. Rally
 - c. Agility
2. AKC rules determine eligibility for all individual performance classes.
3. The Versatility competition must have a minimum of five (5) entries in order to be held.
4. The Versatility entry fee shall be \$25, collected through the entry fee for the Versatility Conformation Class, plus the regular entry fees for Herding, Obedience, Rally and Agility.
 - a. 80 % of entry fees collected will be paid back as follows:

 - b. Ribbons shall be awarded for 1st through 6th place
5. Ties for placements will be broken using the highest Herding score as calculated for Versatility points. If a tie still exists, the dog with the highest number of scores in all events will prevail. If the tie is still not broken, duplicate placements shall be awarded. In the event of duplicate placements for 1st through 4th, paybacks for the tied placement and the corresponding number of following placements will be combined and divided equally between the tied entrants.
6. Computed Versatility scores and standings shall be posted as soon as possible after each eligible competition is completed in a location provided by the Specialty Show host. It is the owner/handler's responsibility to check the scores as posted and report any suspected errors to the designated points keeper at least one hour prior to the scheduled awards presentation. Awards for the Versatility competition shall be final once presented.
7. Only the dog's highest computed Versatility score from each of the performance divisions (Herding, Obedience, Rally, and Agility) will be used for Versatility calculations at full point value. Any and all additional qualifying scores within the same performance division will be valued at 5 points each.
8. Division class eligibility and points determinations for the Versatility competition shall be as follows:

Versatility Conformation

- a. Class is open only to those animals entered in the Versatility competition
- b. An ACD Breeder Judge or present Specialty Judge shall be used
- c. 10 entries or less will be judged together. More than 10 entries will be divided by sex.
- d. Class(es) will be judged by the same criteria as a regular conformation class with the exception that spayed or neutered animals are also eligible.
- e. **All entries shall be placed** with points scored as follows:

- a. The highest **qualifying** score from the Advanced, Intermediate, or Started trial classes shall be used to compute Versatility points as follows:

- b. Highest score in the Herding performance division is defined as the score that will result in the highest number of Versatility points. All other qualifying scores in the Herding performance division will result in an additional five points.

Obedience Performance Division

- a. Regular Obedience: The highest qualifying score from the regular trial Utility, Open or Novice classes shall be used to compute Versatility points as follows:
 Utility: score plus 3% less 100
 Open: score less 100
 Novice: score less 3% less 100
- b. Veterans Obedience: For Versatility scoring purposes, scores of 170 or more from the Veterans obedience class will be considered "qualifying" and Versatility points will be computed as follows:
 Veterans: score less 5% less 100
- c. Highest score in the Obedience performance division is defined as the qualifying regular obedience score or the veteran's obedience score over 170 that will result in the highest number of Versatility points. All other qualifying scores in the Obedience performance division will result in an additional five points.

(Note: Obedience scores have 100 points deducted to equate to attainable scores of the other performance divisions)

Rally Performance Division

- a. The highest **qualifying** score from the Excellent, Advanced or Novice Rally trial classes shall be used to compute Versatility points as follows:
 Excellent: score
 Advanced: score less 3%
 Novice: score less 6%
- b. Highest score in the Rally performance division is defined as the qualifying Rally score that will result in the highest number of Versatility points. All other qualifying scores in the Rally performance division will result in an additional five points.

Agility Performance Division

- a. The highest qualifying score from either the Standard or Jumpers with Weaves agility trial classes, whether regular classes or preferred classes, shall be used to compute Versatility points as follows:
 Clean Excellent Standard or Clean Excellent JWW: 100
 Faulted Excellent Standard or Faulted Excellent JWW: 95
 Clean Excellent Standard Preferred or Clean Excellent JWW Preferred: 95
 Faulted Excellent Standard Preferred or Faulted Excellent JWW Preferred: 90
 Clean Open Standard or Clean Open JWW: 90
 Faulted Open Standard or Faulted Open JWW: 85
 Clean Open Standard Preferred or Clean Open JWW Preferred: 85
 Faulted Open Standard Preferred or Faulted Open JWW Preferred: 80
 Clean Novice Standard or Clean Novice JWW: 80
 Faulted Novice Standard or Faulted Novice JWW: 75

- b. Highest score in the Agility performance division is defined as the qualifying agility score that will result in the highest number of Versatility points. All other qualifying scores in the Agility performance division will result in an additional five points.

Rescue Versatility Award Requirements

- Eligible dogs must have been adopted either from an animal shelter or a verifiable rescue group.
- Proof of adoption must be submitted to ACDRI along with your intent to compete form.
- Dogs must earn a qualifying/passing score in 3 of the 5 following events at the ACDCA National Specialty. In addition they must compete in one herding event which may be a test class.
